An Existence Result for Impulsive Stochastic Functional Differential Equations with Multiple Delays

Abstract

In this paper we consider Impulsive stochastic neutral functional differential equations with multiple delays. By using Schaefer's fixed point theorem, we prove the existence of solutions for stochastic differential equations with impulses.

Introduction

The theory of impulsive differential equations is an important area of scientific activity. Many evolution processes are characterized by the fact that at certain moments of time they experience a change of state abruptly. These short term perturbations act instantaneously, that is in the form of impulses. For example, that many biological phenomena involving thresholds, optimal control models in economics and frequency modulated systems, do exhibit impulsive effects. So the impulsive differential equations appear as a natural description of observed evolution phenomena of several real world problems. Existence of solutions of impulsive differential equations has been studied by many authors. If the impulses are random the solution becomes a stochastic process. Existence of solutions of differential equations with random impulses have been studied by many authors [1-3].

Furthermore, besides impulsive effects, stochastic effects likewise exist in real systems. There is a wide range of interesting process in robotics, economics and biology that can be described as differential equations with non-deterministic dynamics such phenomena are described by stochastic differential equations. The solution of stochastic differential equation is a stochastic process. However the solution of differential equation with random impulses is different from the solution of stochastic differential equations. Existence, Uniqueness and qualitative analysis of solutions of stochastic differential equations have discussed by several authors [4,5].

Since both impulsive and stochastic effects exist it is very difficult to investigate the existence of solution of impulsive stochastic differential equations. In [6] Anguraj and Vinodkumar discussed the existence, uniqueness and stability of impulsive stochastic semi linear neutral functional differential with infinite delays. Lakrib [7] discussed about the existence results for impulsive neutral functional differential equations with multiple delays. Based on the existing literature, stochastic impulsive differential equations involved mainly on controlability and stability. To the best of our knowledge, there is no work reported on impulsive stochastic differential equations with multiple delays. The purpose of this paper is to discuss about the existence results of impulsive stochastic neutral functional differential equations with multiple delays. Our approach is based on Schaefer's fixed point theorem.

In this paper we study the existence results for stochastic impulsive differential equations with multiple delays

where $f: J \times R^n \to R^n$, $g: J \times R^n \to R^n$ and $a: J \times R^n \to R^n$ are Borel Measurable functions, $J_0 = [-r, 0]$, $r = \max \{\tau i : i = 1, 2, ...p\}$ and $\phi: [-r, 0] \to R_n$. Further-more the fixed moments of time t_k satisfy $0 = t_0 < t_1 < ...$. $< t_m < t_{m+1} = 1$, where $x(t_k^+)$ and $x(t_k^-)$ represent the right and left limits of x(t) at $t = t_k$, respectively. And $\Delta x(t = t_k) = x(t_k^+) - x(t_k^-) - x(t_k^-)$, k = 1, 2, ...m represent the jump in the state at time t_k with I_k determining the size of the jump.

Preliminaries

Let $(\overline{\Omega}, \mathbb{F}\{F_t\}_{t\geq 0}, P)$ be a complete probability space with a filtration $\{\operatorname{Ft}\}_{t\geq 0}$ satisfying the conditions that it is right continuous and F_0 contains all P- null sets and $\operatorname{w}(t) = (\operatorname{w}_1(t), \operatorname{w}_m(t))^T$ is an m-dimensional Brownian motion defined on $(\overline{\Omega}, \mathbb{F}\{F_t\}_{t\geq 0}, P)$. Let C = C $[[-r, 0], R^n]$ denote the family of all continuous R_n -valued function φ on [-r, 0] with the norm $\|\phi\| = \sup_{-r \leq \theta \leq 0} |\phi(\theta)|$ where |.| is Euclidean norm of R_n . Denote by $C_{F_0}^b[[-r,0],R^n]$ the family of all bounded F0- measurable, $C[[-r,0],R^n]$ -valued random variables φ , satisfying $\|\phi\|_{L^2}^2 = \sup_{-r \leq \theta \leq 0} E |\phi(\theta)|^2 < \infty$, where E denotes the expectation of stochastic process [8-10]. The initial condition $\phi \in C_E^b[[-r,0],R^n]$.

Let PC(J, Rⁿ) the space of piecewise continuous functions $x: J \to R^n$ such that x is continuous everywhere except for $t=t_k$ at which $x(t_k^-)$ and $x(t_k^+)$ exist and $x(t_k^-) = x(t_k), k = 1, ...m$. If we set $\Omega = \{x: J_1 \to R^n, x \in R^n \cap PC(J, R^n)\}$ where $J_1 = [-r, 1]$ then Ω is a Banach space normed by $\|x\| = \sup\{|x(t)|: t \in J_1\}, x \in \Omega$.

Obviously, for any $x \in \Omega$ and $t \in J$, the function x_t defined by $x_t(\theta) = x(t + \theta)$, for $\theta \in J_0$, belongs to R_n .

By L¹ (J, Rⁿ) we denote the Banach space of measurable functions x: $J \to R^n$ which are Lebesgue integrable, normed by

Definition 2.1: A stochastic process $\{x(t) \in C_{F_0}^b[[-r,0],R^n], t \in [-r,1]\}$, is called a solution of equations (1.1) if

(i) x(t) is F, adapted;

(ii)x(t) satisfies the integral equation

Definition 2.2: (Schaefer fixed point theorem). Let X be a normed linear space and let $\Gamma: X \to X$ be a completely continuous map, that is, it is a continuous mapping which is compact on each bounded subset of X. If the set $\zeta = \{x \in E : \lambda x = \Gamma x \text{ for some } \lambda > 1\}$ is bounded, then Γ has a fixed point [11].

Hypotheses

 H_1 : The function f, g: $J \times R^n \rightarrow R^n$ is such that

for each $t \in [0, 1]$ and c1, c2 > 0 are constants.

 H_2 : The function a: $J \times R^n \to R^n$ is Caratheodory, that is,

- (i) $t \mapsto a(t, x)$ is measurable for each $x \in \mathbb{R}$,
- (ii) $x \mapsto a(t, x)$ is continuous for a.e $t \in J$.

H3: There exists a function $q \in L^1(J, R^n)$ with q(t)>0 for a.e $t \in J$ and a continuous non decreasing function $\psi:[0,\infty) \to [0,\infty)$ such that

Theorem 2.1: Suppose that the conditions $(H_1) - (H_4)$ are satisfied then there exists a solution of the problem (1.1) on $J_1[12-14]$.

Proof: Transform the problem (1.1) – (1.3) into a fixed point problem. Consider the operator $\Gamma:\Omega\to\Omega$ defined by

Step 1: Γ has bounded values for bounded sets in Ω .

Let B be a bounded set in Ω . Then there exists a real number $\rho > 0$ such that $E \|x\|^2 \le \rho$, for all $x \in B$.

Let $x \in B$ and $t \in J$, we have

If $\mathbf{t} \in \mathbf{J}_0$, then $E \|\Gamma \mathbf{x}\|^2 \le \|\phi\|^2$ and hence $E \|\Gamma \mathbf{x}\|^2 \le \eta$ for all $\mathbf{x} \in \mathbf{B}$, that is Γ is bounded on bounded subsets of Ω .

Step 2: Γ maps bounded sets into equicontinuous sets.

Let B be as in Step 1 and $x \in B$. Let t and $h \ne 0$ be such that t, t + h $\in J\setminus\{t_1, t_2,t_m\}$

It remains to examine at t=t_i, i=1, 2, ...m. Let $h \neq 0$ be such that $\{t_k : k \neq i\} \cap [t_i - |h|, t_i - |h|] = \emptyset$ Thus we have

Step 3: Now we show that Γ is continuous

Let $\{x_n\} \subset \Omega$ be a sequence such that $x_n \to x$. We will show that $\Gamma x_n \to \Gamma x$.

Using H_3 it can be easily shown that the function $t\mapsto g(t,x_m)-g(t,x_t)$ is Lebesgue integrable. By the continuity of f and I_k , k=1,2,...m and the dominated convergence theorem, the right hand side of inequality (3.2) tends to zero as $n\to\infty$, which completes the proof that Γ is continuous [15-18].

As a sequence of steps 1 to 3, together with the Arzela-Ascoli theorem, we conclude that Γ is completely continuous.

To complete the proof of the theorem, it suffices to prove the following step.

Step 4:

As a result the conclusion of theorem holds and consequently the problem (1.1) has a solution x on J_1 . This completes the proof [19].
